Sealed proposals will be received by Lucas Local School District in the Treasurer's Office, located in the Elementary Building at, 84 Lucas North Road, Lucas, Ohio 44843, until 2:00.00 PM on Wednesday, May 1, 2019, at which time and place proposals will be opened publicly and read aloud. Proposals received after 2:00.00 PM on Wednesday, May 1, 2019 will be returned unopened. Proposals shall be for the furnishing of materials and the performance of labor necessary for the:

For each contract a Lump Sum bid will be received. Contractors may choose to submit proposals on any of the project contracts, and may also decline to submit proposals on any of the project contracts.

A prebid meeting will be held at 2:00 PM on Friday, April 12, 2019 at the Elementary Building, 84 North Lucas Road, Lucas, Ohio 44843. The pre-bid meeting is not mandatory but bidders are strongly encouraged to attend. The facility will be open for inspection at this time.

A Bid Security in the form of a certified check, cashier's check, irrevocable letter of credit, or surety company bond pursuant to Chapter 1305 of the Ohio Revised code in the amount of 10% of the total bid shall accompany each bid; or a bid guaranty bond in accordance with Chapter 153.571 of the Ohio Revised Code in the amount of 100% of the total bid shall accompany each bid.

If a bid security in the amount of 10% of the full bid amount is submitted with this bid, each successful bidder is required to furnish a Performance Bond and Labor and Material Bond from an acceptable surety in the amount of 100% of the full contract amount in accordance with Section 153.571 of the Ohio Revised Code.

If a bid guaranty bond in the amount of 100% of the total bid is submitted with the bid, no additional Performance and Labor and Material Bond is required to be furnished by the successful Bidder.
